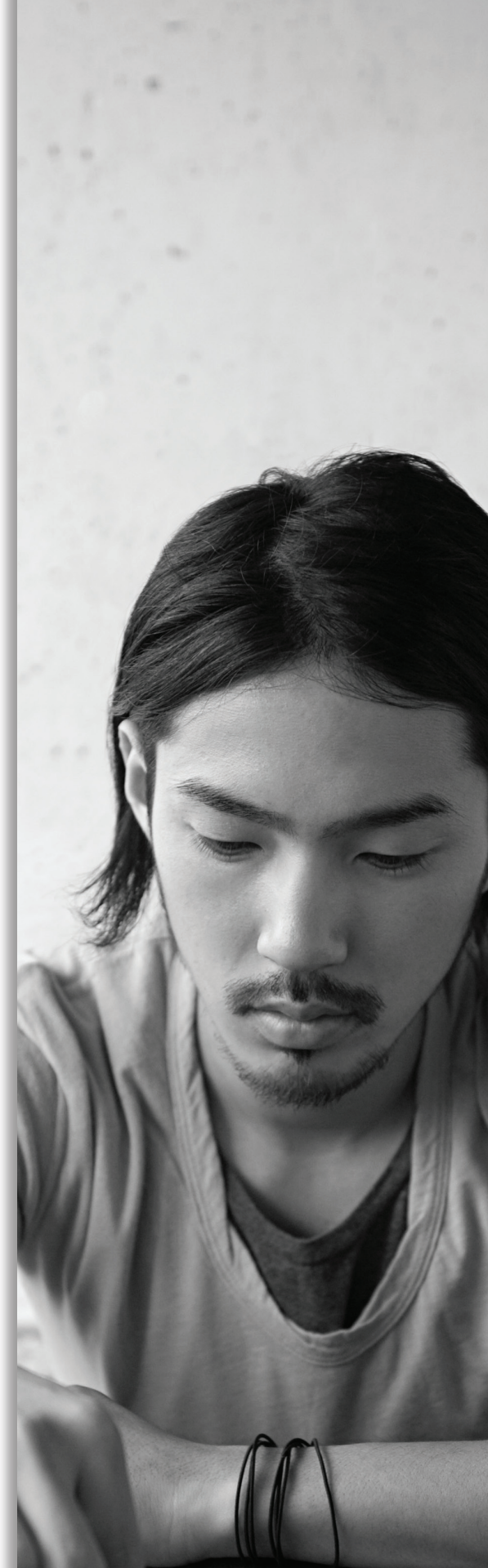
Assessing and managing Asian cases can present a significant challenge to court officials and probation officers who are not fluent in the specific Asian language or culture.

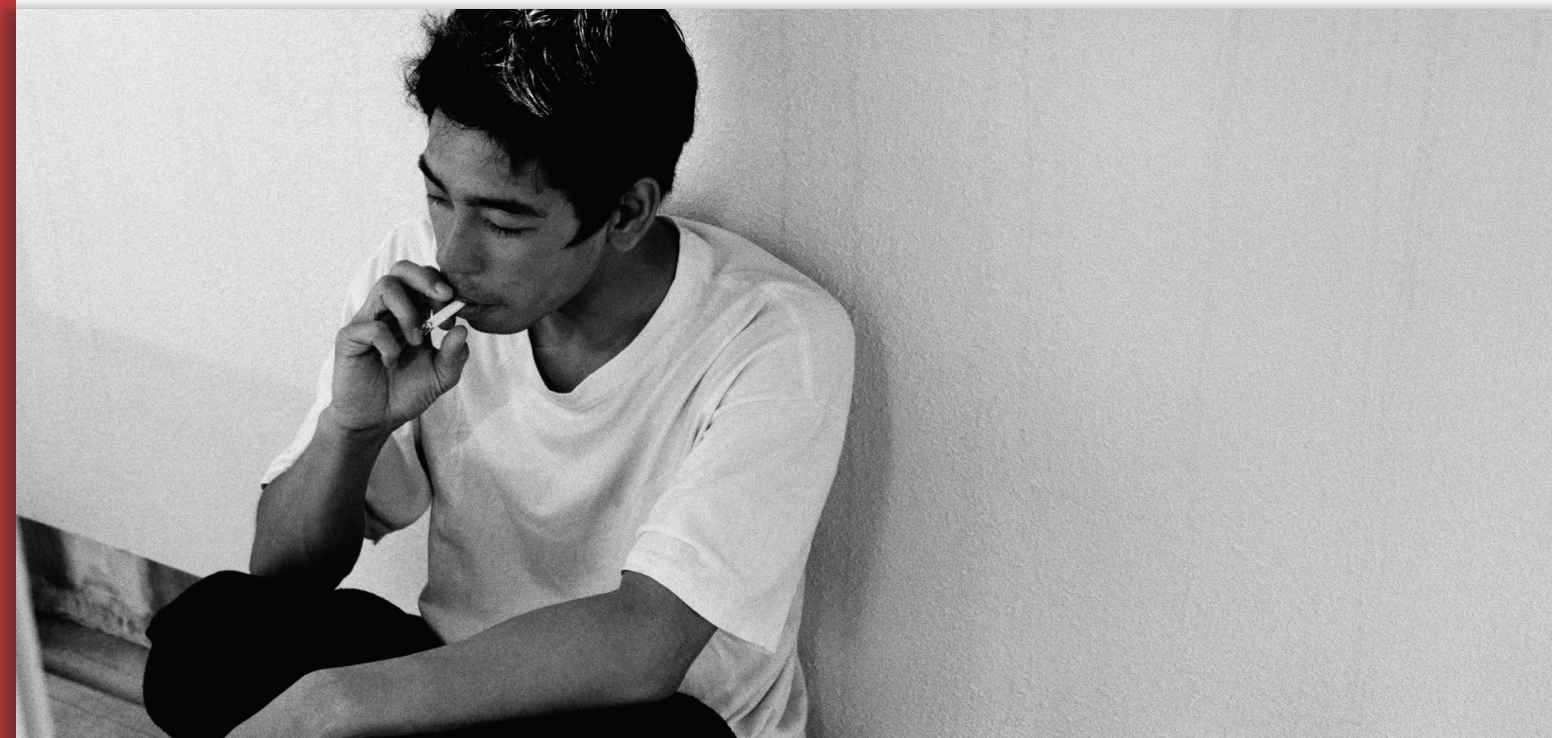
What next?

For example, Hamilton-Madison House Recovery Services established the first OASAS-Certified Asian Alcoholism outpatient clinic in New York. Services include ambulatory detoxification and referral to inpatient detoxification. Individual, family and group counseling are also provided, along with medical and psychiatric evaluation and treatment.

Our mental health facilities are licensed, state-of-the art treatment centers that serve multi-Asian communities, including Chinese, Japanese, Korean and Southeast Asian populations. We offer counseling, prevention, and rehabilitative services on an outpatient basis to mentally ill and chemically-dependent clients.

In addition, we can provide independent housing, pre-vocational skills training and employment assistance. Our support services include bilingual and bicultural case management, and culturally appropriate intervention when needed.
